This information is provided pursuant to article 13 of EU Regulation 2016/679 (GDPR) to those who have access to the website www.cemeteryrome.it (the "Site")

When you access the Site, the "Privacy" button on every page links you to information informing you that (i) third-party analytics cookies are used on the site and that (ii) closing the Privacy Statement, scrolling the page or clicking any element of the page outside the button, you are consenting to the use of cookies.

By accessing and/or browsing within the www.cemeteryrome.it website, data relating to identified or identifiable persons may be processed.

The information below is provided only for the www.cemeteryrome.it and not for the other websites that may be consulted by the user through the links contained therein.

- 1. management of the website;
- 2. analysis of access and navigation statistics;
- 3. management of donations;
- 4. management of the Friends of the Cemetery.

Processing methods and storage time

The Non-Catholic Cemetery processes the data freely entered by the user on the Site or on the "Friends of the Cemetery" page (http://cemeteryrome.it/support/brochure2015-EN.pdf), such as personal data, contact details, telephone or fax numbers , email addresses, data contained in notes or comments, as well as autonomously generated technical data (in particular, IP addresses, log files relating to navigation on the Site, purchases made, etc.).

The data relating to donations are managed through third parties such as PayPal.

Personal data are processed with automated tools for the time strictly necessary to achieve the purposes for which they are collected and in any case, when the browser is closed, information will only be kept and processed anonymously.

Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access.

The site of data processing and subjects that they process

Data treatment connected to the web services of this Site takes place in Florence at the Genesys Informatica S.r.l. Data Center, and are conducted by authorized personnel.

Navigation data

During their normal operation, the IT systems and software procedures used to operate this Website acquire some personal data whose transmission is implicit in the use of internet communication protocols.

The Non-Catholic Cemetery informs you that while browsing from the address www.cemeteryrome.it corresponding to the official Site home page, the following is collected for example:

- IP address;
- Page of origin;
- Type of browser used by the navigator (intended as the one who accesses the Site);
- The operating system used by the browser (intended as the one who accesses the Site).

The navigation data mentioned above are used for the sole purpose of obtaining anonymous statistical information on the use of the Site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in the event of unlawful damage to the Site or the Non-Catholic Cemetery.

Optional supply of data and processing of data voluntarily provided by the user / interested party

Sending, for any reason, email messages to the email addresses indicated on the website www.cemeteryrome.it, involves the subsequent acquisition of the sender, necessary to respond to email communications, as well as any other data entered in the email, which will be processed for the sole purpose of following up the request of the sender of the email and may only be communicated to third parties involved in the fulfillment of the request (for this purpose, the Non-Catholic Cemetery could make use of suppliers or professionals who offer relevant advice or services to the treatment to be conducted).

It is understood that if, for any reason, the communications forwarded by the user / interested party on their own initiative or not necessary in respect to the treatment that the Non-Catholic Cemetery carries out / intends to carry out, the Non-Catholic Cemetery reserves the right to immediately delete the data or in any case to treat the data in such a way as not to create organizational and legal repercussions that are considered to be in contrast with the personal data management system in force in the Non-Catholic Cemetery.

Specific information for the protection of data (articles 13 and 14 GDPR) where necessary, will be prepared and can be viewed in the individual sections of the Site which may contain requests for personal data for treatments not related to this information.

Subsequently, if the Non-Catholic Cemetery should follow a selection process, you will be asked again for a specific piece of information and consensus, where necessary.

Anyone browsing the www.cemeteryrome.it website (interested in data processing) acknowledges that, both for technical limitations and for the fact that the company keeps back-ups of its data, some types of information may continue to persist in the systems even after the cancellation (for a variable period of time and in any case correlated exclusively with the backup procedures and with the disaster recovery plan).

MONITORING COOKIES OR "ANALYTICS"

Rights of the interested parties and data controller
